Vinod Bhatia, CFA®

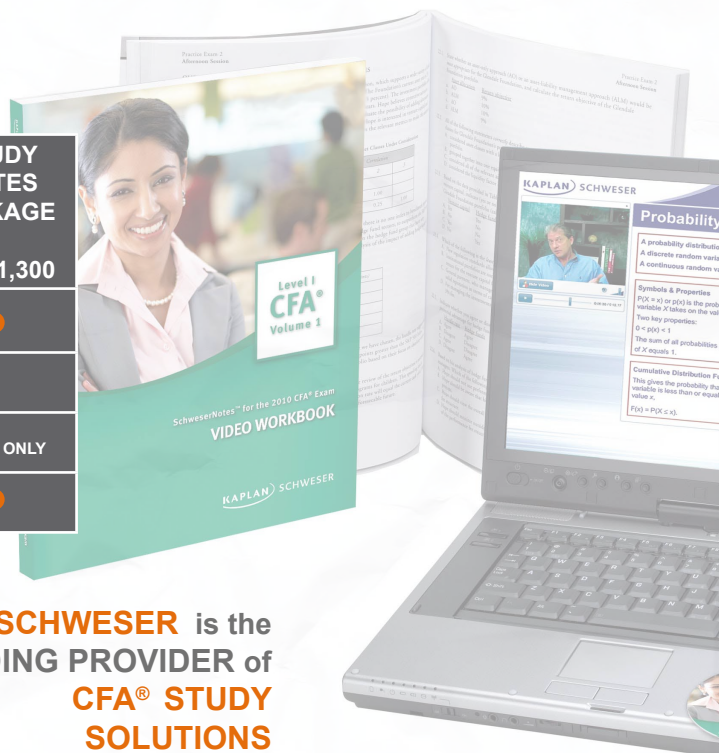
